In Attendance:

Call to Order

April called the meeting to order at 11:02 AM.

Item to Discuss:

Legal counsel presents at PYLUSD Board Meeting.

Dr. Fisher let us know that Dr. Abtin Khosarvi a voting member of the Advisory Council is currently in surgery and would like to make an absentee vote of Yes.

The Importance of this meeting is to advocate for our learners, sharing with our governance structure. Dr. Doug Fisher reviewed the agenda and having our attorney present is legally permissible and the acting superintendent and board should not treat us different than their peers. Dr. Beth Fisher presence should be allowed in closed session, this is not an unethical nor is illegal.

The pending litigation may mislead the public, our item should not be that long. It should provide legal statues. We need to confirm that we get the same time alloted to present that Sukhi does.

We need to check with Greta to be there, if there is a mistake in Section D, they can request a revision, but they cannot shut us down


Parents and the community need to speak up. Greta needs to have equal time, as Sukhi.

Carrie Buck is trying to scrutinize the Charters. Fox advocates for charters/distrists.

There is a motion on the table for the Advisory council to pay Greta Proctor to speak on behalf of OCSCS Charter and Fisher put forth by April G. And a second by Mr. James Goodwin.

Ariana Drivdal brought up a concern about keeping Fisher out of signing it, Brianna trump stated she could sign, April as the council president stated she could sign.

It is not stated that Greta charges by the tenth hour, and requires a \$5000 retainer. Is there someone who can some up with this one. Dr. Beth Fisher reached out to her father to see if he could help, it was asked if this would be a conflict of interest.

Dr. Olivia Young isn't board attorney. Board will side with what their attorney says, if approved we will retain all of ADA. Can they put limits on the ADA. Would we be having to go back every 5 years for this,

The longer game opportunities for ADA will be spelled for MOU.

The Autonomus structure give us more access to grant money.


Would we want to continue to pass up 2 grant cycles. 46 out of the 47 charters in Orange County current have autonomus structures.
